**Constitutional Rights**

**Gov Cai Muaj Hauv Teb Chaws Meskas No**

I understand that by entering this plea, I give up the following constitutional rights:

*Kuv nkag siab hais tias yog kuv lees txhaum lawm, kuv tso kuv cov cai hauv qab no tseg:*

I give up my right to a trial.

*Kuv tso txoj cai coj rooj plaub mus hais kom muaj siab muaj swb.*

I give up my right to remain silent and I understand that my silence could not be used against me at trial.

*Kuv tso kuv txoj cai uas tsis hais lus li thiab kuv nkag siab hais tias kev tsis hais lus no yuav coj los siv foob tsis tau kuv hauv thaum hais plaub muaj yeej muaj swb.*

I give up my right to testify and present evidence at trial.

*Kuv tso kuv txoj cai los teev lus thiab nthuav pov thawj thaum hais plaub muaj yeej muaj swb.*

I give up my right to use subpoenas to require witnesses to come to court and testify for me at trial.

I give up my right to a jury trial, where all 12 jurors would have to agree that I am either guilty or not guilty.

Kuv tso kuv txoj cai hais plaub kom muaj yeej muaj swb tim ntej tim muag ntawm cov pej xeem txiav txim, uas muaj 12 tus pej xeem txiav txim yuav tsum pom zoo hais tias kuv tau ua txhaum los tsis txhaum.

I give up my right to confront in court the people who testify against me and cross-examine them.

I give up my right to make the State prove me guilty beyond a reasonable doubt.

I understand the rights that have been checked and give them up of my own free will.

**Understandings**

**Kev To Taub**

- I understand that the crime(s) to which I am pleading has/have elements that the State would have to prove beyond a reasonable doubt if I had a trial. These elements have been explained to me by my attorney or are as follows:  See Attached sheet

Kuv to taub hais tias lub txim lossis cov txim uas kuv tab tom yuav lees no lub Xeev yuav tsum muaj pov thawj txaus yam tsis muaj kev xav tias kuv tsis tau ua li yog coj mus hais kom muaj yeeb muaj swb. Cov nqe lus no yeej tau coj los piav rau kuv tus kws lij choj lawm lossis muaj raws li nram qab no: Saib Daim Ntawv Txuas Ntxiv

- I understand that the judge is not bound by any plea agreement or recommendations and may impose the maximum penalty. The maximum penalty I face upon conviction is:

Kuv to taub hais tias tus thawj txiav txim tsis tas ua li daim ntawv cog lus kev lees no lossis cov lus pom zoo thiab kuj phua lub txim nyhav tshaj plaws. Lub txim nyhav tshaj plaws yuav phua rau kuv yog hais tias muaj kev txiav txim hais tias kuv tau ua txhaum lawm yog:

- I understand that the judge must impose the mandatory minimum penalty, if any. The mandatory minimum penalty I face upon conviction is:

Kuv to taub hais tias tus thawj txiav txim yuav tsum phua lub txim uas tsis pub qis tshaj, yog hais tias muaj lub txim ntawv. Lub txim uas tsis pub qis tshaj uas yuav phua rau kuv yog hais tias kuv swb rooj plaub lawm yog:

- I understand that the presumptive minimum penalty, if any, I face upon conviction is:

The judge can impose a lesser sentence if the judge states appropriate reasons.

**Understandings**

**Kev To Taub**

- I understand that if I am placed on probation and my probation is revoked:
  - if sentence is withheld, the judge could sentence me to the maximum penalty, or
    - Yog hais tias kev phua txim muab tuav tseg, tus thawj txiav txim muaj cai phua lub txim kom nyhav tshaj plaws, lossis
  - if sentence is imposed and stayed, I will be required to serve that sentence.
    - Yog hais tias lub txim phua tau lawm thiab kom siv mus, kuv yuav tau mus pw lub txim ntawv.
- I understand that if I am not a citizen of the United States, my plea could result in deportation, the exclusion of admission to this country, or the denial of naturalization under federal law.
  - Kuv to taub hais tias yog hais tias kuv tsis tau yog neeg meskas, kuv txoj kev lees no kuj yuav xa tau kuv rov qab, txwv tsis pub rov qab tuaj rau lub teb chaws no, lossis tsis pub ua neeg meskas raws li lub teb chaws meskas cov kev cai.
- I understand that if I am convicted of any felony, I may not vote in any election until my civil rights are restored.
  - Kuv to taub hais tias kuv swb luv txim loj hu ua felony, tej zaum kuv yuav pov tsis tau npav txog thaum kuv rov qab mus thov tau cai pov.
- I understand that if I am convicted of any felony, it is unlawful for me to possess a firearm.

*Kuv to taub hais tias kuv swb luv txim loj hu ua felony, kuv yuav tsis muaj cai ceev phom lawm.*

- I understand that if I am convicted of any violent felony, it is unlawful for me to possess body armor.

*Kuv to taub hais tias kuv swb luv txim loj hu ua felony yam ntaus tib neeg, kuv yuav tsis muaj cai ceev khoom tib thaiv lub cev lawm.*

- I understand that if I am convicted of a serious child sex offense, I cannot engage in an occupation or participate in a volunteer position that requires me to work or interact primarily and directly with children under the age of 16.

*Kuv to taub hais tias kuv swb luv txim uas quab yuam menyuaem yaus ua dev ua npua, kuv yuav ua tsis tau cov haujlwm lssis mus ua haujlwm pub dawb uas yuav muaj kev sib txuas lus nrog rau cov menyuaem uas tsis tau muaj 16 xyoo.*

- I understand that if any charges are read-in as part of a plea agreement they have the following effects:

*Kuv to taub hais tias yog muaj cov txim uas coj los nyeem vim txoj kev sib khom los lees txhaum no yuav muaj cov nram qab no tshwm sim:*

- Sentencing – although the judge may consider read-in charges when imposing sentence, the maximum penalty will not be increased.

*Phua Txim – txawm hais tias tus thawj txiav txim yuav muaj cov txim coj los nyeem ntawv ntau nqi lthaum losp hua lub txim los, lub txim uas nyhav tshaj plaws yuav tsis loj tshaj ntxiv.*

- Restitution – I may be required to pay restitution on any read-in charges.

*Them Nqi – Kuv kuj yuav raug them nqi rau cov txim coj los nyeem ntawv.*

- Future prosecution – the State may not prosecute me for any read-in charges.

*Foob yav pem suab – lub Xeev yuav foob tsis tau ntxiv txog cov txim uas coj los nyeem lawm.*

- I understand that if the judge accepts my plea, the judge will find me guilty of the crime(s) to which I am pleading based upon the facts in the criminal complaint and/or the preliminary examination and/or as stated in court.
