Before Curley, P.J.

By order dated May 27, 2016, this court directed Attorney Kiley Zellner to file a supplemental no-merit report on behalf of Chaz Landon Holifield. Upon this court's independent review of the record and the no-merit report, we noted a possible issue relating to use of the domestic abuse modifier on some of the charges in these appeals.

Attorney Zellner, on behalf of Holifield, now moves to dismiss the appeals and seeks an extension of time for filing a postconviction motion in order to address the issue of arguable

merit that counsel concluded does exist. Counsel further represents that Holifield agrees with

this course of action. Because a no-merit report is only appropriate if counsel is convinced that

an appeal would be wholly frivolous, see McCoy v. Court of Appeals, 486 U.S. 429, 437 (1988),

this court will grant the motion.

Upon the foregoing,

IT IS ORDERED that the no-merit report in appeal Nos. 2015AP2206-CRNM,

2015AP2207-CRNM, 2015AP2208-CRNM, and 2015AP2209-CRNM is rejected and the

appeals are dismissed without prejudice.

IT IS FURTHER ORDERED that the deadline for filing a postconviction motion or

notice of appeal in Milwaukee County Circuit Court case Nos. 2014CF1374, 2014CF1619,

2014CF4629, and 2015CF472 is extended to August 29, 2016.
