2015AP727-CRNM State of Wisconsin v. Corey J. Uhlenberg (L.C. # 2011CF80)

Before Neubauer, C.J., Reilly, P.J., and Gundrum, J.

Counsel for the appellant indicates that after filing the no-merit notice of appeal counsel discovered an issue of arguable merit requiring a postconviction motion. Counsel moves to voluntarily dismiss the appeal, WIS. STAT. RULE 809.18, in favor of an extension of time to file a postconviction motion under RULE 809.30. Good cause exists for the extension.

Finally, the appellant has filed a letter in this court expressing an interesting in pursuing a motion for plea withdrawal. Because the appellant is represented by counsel, we need not

address the letter. *See State v. Debra A.E.*, 188 Wis. 2d 111, 138, 523 N.W.2d 727 (1994) (a defendant does not have a right to hybrid representation in matters before this court). However, as a courtesy to counsel, we include a copy of the letter with this opinion and order. Therefore,

IT IS ORDERED that the appeal is dismissed pursuant to WIS. STAT. RULE 809.18.

IT IS FURTHER ORDERED that the time for filing a notice of appeal or postconviction motion under WIS. STAT. RULE 809.30, is extended to October 21, 2016. *See* WIS. STAT. RULE 809.82(2)(a).
