2015AP1670-CRNM State of Wisconsin v. Gustave K. Benson (L.C. # 2013CF1001)

Before Neubauer, C.J., Gundrum and Hagedorn, JJ.

Gustave Benson appeals from a judgment convicting him of attempted second-degree sexual assault of a child under sixteen contrary to WIS. STAT. §§ 948.02(2) and 939.32 (2013-14).<sup>1</sup> Benson's appellate counsel filed a no-merit report pursuant to WIS. STAT. RULE 809.32 and *Anders v. California*, 386 U.S. 738 (1967). Our October 21, 2016 order identified a sentence credit issue in the record.

Appointed counsel advises that the sentence credit issue will be addressed via a WIS. STAT. RULE 809.30 postconviction motion, and that this appeal may be dismissed. The court will grant the requested relief.

Upon the foregoing reasons,

IT IS ORDERED that the WIS. STAT. RULE 809.32 no-merit report is rejected.

IT IS FURTHER ORDERED that this appeal is dismissed in favor of WIS. STAT. RULE 809.30 proceedings in the circuit court.

IT IS FURTHER ORDERED that a WIS. STAT. RULE 809.30 postconviction motion shall be filed in the circuit court within sixty days of the date of this order.
