<b>Purpose of Form:</b>	To request that a child be taken into temporary physical custody in a Chapter 48 proceeding and to record the decision of the juvenile intake worker concerning the custody decision.

<b>Comments:</b>	<p>If the caseworker does not have the supplemental information ready or available, an amended IW-1608 can be filed.</p> <p>For use in taking into custody under Chapter 48 CHIPS, a child for whom there exists a reasonable belief that the child is an Indian child. Provides ICWA-required information to the court.</p> <p>The legal status categories are defined as follows:</p> <p><b>Birth</b> – Parent who physically delivered the child.</p> <p><b>Adoptive</b> – Parent who adopted the child by court order.</p> <p><b>Adjudicated</b> - Parent based on a court order establishing paternity</p>

or parentage or who is the administratively adjudicated parent due to the filing of a paternity acknowledgement form with the Office of Vital Records.

**Marital** – Parent who is presumed to be the biological parent because the child was conceived or born during marriage, or is presumed to be the biological parent because the marriage occurred after the child's birth but the parties had a relationship at the time of conception.

**NOTE:** The marital presumption does not apply if a court has found another person to be the parent instead of this parent. It also doesn't apply if the marriage followed the birth but the child was conceived or born during a marriage to another.

For temporary physical custody requests in a Chapter 938 Delinquency proceeding, use circuit court form JD-1710.
