Summary disposition orders may not be cited in any court of this state as precedent or authority, except for the limited purposes specified in WIS. STAT. RULE 809.23(3).

Appellate counsel for D.E. filed a no-merit report in this matter. *See* WIS. STAT. RULE 809.32 (2023-24).¹ By order dated June 5, 2025, we directed appellate counsel to file a jurisdictional memorandum and a supplemental no-merit report, or, alternatively, a request for

appropriate relief. Appellate counsel now requests voluntary dismissal of this appeal and an extension of appellate deadlines. Upon review, the court will grant the requested relief. Appellate counsel does not estimate the length of the extension required. The court will establish an appropriate deadline that accommodates this court's procedures at remittitur.

Therefore,

IT IS ORDERED that the hold previously imposed in this matter is lifted.

IT IS FURTHER ORDERED that the no-merit report in this matter is rejected and this appeal is dismissed without prejudice. *See* WIS. STAT. RULE 809.18(1).

IT IS FURTHER ORDERED that the deadline for D.E. to file a postdisposition motion or a notice of appeal pursuant to WIS. STAT. RULE 809.30 is extended through the date sixty days after remittitur. *See* WIS. STAT. RULE 809.82(2)(a).

IT IS FURTHER ORDERED that this summary disposition order will not be published.
