#### **NEW LEGISLATION**

2005 WI Act 317: Increased penalty for Absolute Sobriety Sec. 346.65(2q) – This legislation was just signed into law on April 10, 2006. It increases the forfeiture from **\$10** to **\$200**. Please note that although this change will become effective after publication (publication date is unknown at this time), the bond book will not be amended to reflect this change until January 2007.

#### **OTHER LEGISLATION**

Set forth below is a list of recent legislative changes that impact municipal courts:

- 2005 WI Act 190 -Municipal Court Jurisdiction over juveniles 12 – 15 years of age, for traffic offenses
- 2005 WI Act 191 Request for Jury Trial on Appeal from Municipal Court
- 2005 WI Act 192 Noncompliance with a Municipal Court Order
- 2005 WI Act 116 Municipal Adult Drug Paraphernalia Ordinances
- 2005 WI Act 54 Increase in Municipal Court Costs
- 2005 WI Act 59 Collection Procedures Affecting Courts

#### UPCOMING SEMINARS

#### ORIENTATION AND INSTITUTE

This year's Orientation & Institute Seminar will be held May 10, 11 & 12, 2006, at the Heidel House Resort in Green Lake. All new judges are required to attend this seminar. The purpose of the Institute is to provide a review of the basics of operating a municipal court. For this reason the agenda topics do not change from year to year.
