Wisconsin Court System website (www.wicourts.gov)

The website provides a variety of useful materials including case information on circuit court and appellate court cases, Supreme Court and Court of Appeals opinions from 1995 to present, audio of Supreme Court oral arguments from 1997 to present, and live audio of Supreme Court proceedings as they are occurring. The website contains biographies of all current and past justices; information on the courts' many programs and initiatives; a directory of all court system staff; *The Third Branch*, a quarterly newsletter of the Wisconsin judiciary; and much more.

Wisconsin Circuit Court Access (WCCA) and Wisconsin Supreme Court and Court of Appeals Case Access (WSSCA)

WCCA was created in response to an increasing number of requests for court records from district attorneys, sheriffs' departments, and other court business partners. Title companies, abstractors, members of the media and the general public have also benefited from WCCA. Access WCCA at: www.wicourts.gov under "Case Search."

WSSCA provides public access to the status of appeals filed with the Wisconsin Supreme Court and the Wisconsin Court of Appeals. Generally, this site includes appeals that were considered "Open" from the end of 1993 forward.
