Issues presented:

- 1. Did the chief deprive Officer Andrade of due process by failing to provide an explanation of his evidence supporting his decision to discharge Officer Andrade?
- 2. Did the chief deprive Officer Andrade of due process by failing to comply with §62.50(13), Stats.?

Review denied: The Supreme Court denied review in the following cases. As the state's lawdeveloping court, the Supreme Court exercises its discretion to select for review only those cases that fit certain <u>statutory criteria</u> (see Wis. Stat. § 809.62).
