- A. <u>Information Item</u>: Rule Petition 08-01A (Juries). Rule Petition 08-01 amended ch. 756, specifically changing the number of jurors for a misdemeanor case from 6 to 12 under Wis. Stat. § 756.06(2)(am). Wis Stat. § 972.02(2) references a misdemeanor jury of 6; needs clean-up amendment. Staff memo and draft order circulated 9/5/12. Court discussed at 9/19/12 open conference. **Court agreed to refer to legislature.** Communication made to Nancy Rottier. Proposed bill distributed to court by e-mail 11/29/12.
- B. <u>Information Item</u>: Rule Petition 09-07: In the Matter of: The Petition of the State Bar of Wisconsin to Modify Chapter 72 of the Supreme Court Rules filed 06/30/09 by Diane S. Diel, President, State Bar of Wisconsin. Amended petition filed 10/27/09 by Douglas W. Kammer, President, State Bar of Wisconsin. **Pending before Legislative Committee of Judicial Conference.**
- C. <u>Information Item</u>: Rule Petition 10-09: In the Matter of the Petition for Amendment of various Rules in Chapter SCR 20 filed 10/21/10 by John Nicholas Schweitzer. **Returned to Mr. Schweitzer.**
- D. <u>Information Item</u>: Rule Petition 12-08: Petition to create SCR 74.02, Appointment of the Judicial Commission Members filed 7/31/12 by Chief Justice Shirley S. Abrahamson. Preliminary memo circulated 9/17/12. Court discussed at 9/19/12 and 9/25/12 open conferences. Court voted 4-3 not to hold public hearing and to deny petition. **Draft order circulated on 10/15/12; approvals received from all justices; SSA writing to follow.**
- E. <u>Information Item</u>: 2011 Wisconsin Act 209 creating a fee waiver program for veterans. Under the legislation, veterans who meet the eligibility requirements would receive a waiver of the initial licensing fee for most licenses granted by state agencies. The act also requests the Supreme Court to promulgate a rule waiving the initial admission fee for lawyers admitted to practice. <u>See</u> § 751.153. Letter to BBE & State Bar (sent 6/7/12) referring the matter for consideration and determination of whether a petition seeking a change to the court rules might be appropriate; response received. Staff memo circulated 9/7/12. Court discussed at 9/25/12 open conference. Court voted to request that BBE file rule petition. **Letter to BBE requesting filing of rule petition sent 10/16/12.**
