

Flattening PDFs

If you receive an upload rejected error message stating "PDF contains form content," your document contains some complex elements—such as editable text fields, comments, or signatures. To rectify this, you will need to flatten your PDF to convert these elements into a simple, "flat" image. The easiest method to do so is to use the "Print to PDF" feature in Adobe Acrobat or in Google Chrome. **Note:** This process can also be used to reduce the size of a PDF.

Documents

Upload your filing document and additional documents below.

- The choices available in the document type menu below will fill in appropriately depending on an uploaded document's format (.pdf or .docx).
- Documents must be less than 10 MB in size and standard letter or legal size.
- Do not include the signature block on proposed orders.
- For more details on technical requirements for documents see the support page.

To upload multiple documents using Firefox, Chrome and Internet Explorer 10 or higher, first select a file you want to upload and then press and hold the Ctrl key while selecting each of the other files to upload.

Adobe Acrobat

- 1. In Adobe Acrobat, open the PDF you need to flatten.
- 2. Select File > Print.

3. Select the **Printer** dropdown and choose **any option that has PDF in the title**. Change the **Comments & Forms** dropdown to **Document**. Select the **Print** button.


4. Choose a location to save your new PDF and enter a new name to differentiate it from your original version. Select the **Save** button.

Google Chrome

1. Open a Google Chrome browser window and drag your PDF file into it.



2. Select the **Print icon** in Chrome's PDF viewer. Alternatively, you can select **Ctrl + P**.
