A Petition for Review of Conduct of Guardian was filed and a hearing has been held. After consideration of the reports and other documents on file, all factors required by the statutes, and such additional information presented;

**THE COURT FINDS:**

- 1. The allegations in the Petition **have not been proven.**

  - failed to exercise due diligence and reasonable care ensuring that the ward's personal needs are being met in the least restrictive environment consistent with the ward's needs and incapacities.
  - failed to act in the best interest of the ward.
  - failed to disclose conviction for a crime that would have prevented appointment of the person as guardian.
  - failed to disclose that the guardian is listed in the Caregiver Misconduct Registry under §146.40(4g)(a)2, Wis. Stats.
  - failed to perform any duties of a guardian or performed acts prohibited to a guardian as specified in §§54.18, 54.19, 54.20, 54.22, 54.25, and 54.62, Wis. Stats.
- 3. Changed circumstances indicate that a previously unavailable volunteer guardian is available to serve as guardian and that the change is in the best interests of the ward.
