**TO THE JUVENILE:
RAU TUS MENYUAM:**

You have the right to seek relief from the judgment in this case. If you were represented by a lawyer at your disposition, it is that lawyer's responsibility to assist you in deciding whether to seek postdisposition relief.

Koj muaj cai los nrhiav kev cawm ntwam txoj kev txiax txim zaum no. Yog hais tias muaj ib tug kws lij choj tuaj sawv cev rau koj thaum lub sijhawm txiax txim, yog tus kws lij choj lub luag haujlwm los pab koj txiax txim siab saib puas tsum nyog nrhiav kev cawm tom qab twb txiax txim tag lawm.

If you decide to seek postdisposition relief, you or your lawyer must file a Notice of Intent to Seek Postdisposition Relief. The Notice of Intent must be filed in the trial court within 20 days. If you had a lawyer at your disposition, and if you give your lawyer timely notice that you have decided to seek postdisposition relief, it is your lawyer's duty to see that your Notice of Intent is properly filed in this court and served on the District Attorney.

Yog hais tias koj txiax txim siab nrhiav kev cawm tom qab twb txiax txim tag lawm, koj lossis koj tus kws lij choj yuav tsum xa daim ntawv muaj npe hu ua Notice of Intent to Seek Postdisposition Relief. Daim ntawv Notice of Intent yuav tsum xa tuaj rau lub tsev hais plaub tsis pub dhau 20 hnuv. Yog hais tias koj muaj ib tug kws lij choj tuaj sawv cev rau koj thaum los txiax txim zaum kawg, thiab koj yeej ceeb toom rau tus kws lij choj ntawv yam muab sijhawm txaus es qhia rau nws hais tias koj tau los txiax txim siab nrhiav kev cawm tom qab twb txiax txim tag lawm ces, yog tus kws lij choj lub luag haujlwm los soj kom daim ntawv Notice of Intent raug xa tuaj rau ntwam lub tsev hais plaub no thiab xa ib daim mus rau tus Kws Lij Choj Hauv Zos no.

After filing the Notice of Intent, your lawyer does not have to represent you further unless you hire him or her to do so. If you intend to seek postdisposition relief but cannot afford a lawyer, you have the right to request that a lawyer be appointed to assist you by the State Public Defender.

Tom qab koj xa daim ntawv Notice of Intent, koj tus kws lij choj tsis tas tuaj sawv cev rau koj lawm yuav tsum yog koj rov qab ntiav nws tuaj xwb. Yog hais tias koj xav nrhiav kev cawm tom qab twb txiax txim tag lawm tab sis koj tsis muaj nyiaj ntiav tus kws lij choj, koj muaj cai thov kom tau ib tug kws lij choj los pab koj dawb uas yog tuaj ntwam State Public Defender tuaj.

**JUVENILE'S STATEMENT:
MENYUAM COV LUS TEEV:**

I have discussed my right to seek postdisposition relief with my lawyer, if any, who represented me at disposition. I understand that if I intend to seek postdisposition relief, I must file a Notice of Intent in the trial court within 20 days after disposition and send a copy to the District Attorney. If I want my lawyer to file the Notice of Intent for me, I must timely inform my lawyer of my decision to seek postdisposition relief. I have received a copy of this Notice.

Kuv twb tau sab laj txog txoj kev nrhiav kev cawm tom qab twb txiax txim tag nrog rau kuv tus kws lij choj lawm, yog muaj, tus uas tuaj sawv cev rau kuv thaum los txiax txim ntwawv. Kuv nkag siab zoo hais tias yog kuv xav nrhiav kev cawm tom qab twb txiax txim tag lawm, kuv yuav tsum xa daim ntawv Notice of Intent tuaj rau lub tsev hais plaub tsis pub dhau 20 hnuv tom qab kev txiax txim tag thiab xa ib daim qauv mus rau tus Kws Lij Choj Hauv Zos. Yog hais kuv xav kom kuv tus kws lij choj pab xa daim ntawv no, kuv yuav tsum ceeb toom rau nws thiab muab sijhawm kom txaus txog kuv txoj kev txiax txim siab nrhiav kev cawm tom qab qhov kev txiax txim zaum kawg no. Kuv tau ib daim qauv ntwam daim Ntawv Ceeb Toom no.

**ATTORNEY STATEMENT:

I believe the juvenile understands the right to postdisposition relief and the 20 day time limit. I understand that it is my duty to file the Notice of Intent to Pursue Postdisposition Relief on behalf of the juvenile if that intent is timely communicated to me.
