THE COURT FINDS: / TSEV HAIS PLAUB POM TIAS:

1. The child/juvenile was provided legal counsel through the State Public Defender Office in the above captioned case.

2. The child/juvenile has been/ *Tus menyuam/tus hluas:*
 - adjudicated delinquent.

 - adjudicated in violation of a civil law or ordinance.
tau raug txiav txim tias ua txhaum neeg txoj cai los sis kev cai hauv zos.
 - adjudicated in need of protection or services.
tau raug txiav txim tias kom muaj kev tiv thaiv los sis cov kev pab.
 - released with no adjudication.
tso mus yam tsis muaj kev txiav txim dab tsi.
 - the subject of a petition that was dismissed without an adjudication.

 - the subject of a request for revision/extension/change of placement/permanency plan review.

3. The State Public Defender Office established that the amount of reimbursement shall be \$480 in felony matters and \$240 for all other cases.
Xeev Tus Kws Lij Choj Dawb Qhov Chaw Ua Hauj Lwm (State Public Defender Office) tau tsim tias tus nqi uas yuav tau them rov qab yuav yog \$480 rau cov plaub ntug uas muaj txim loj thiab \$240 rau tag nrho lwm cov plaub ntug.
4. The parents were not the complaining or petitioning party and the interests of the child/juvenile and parents are such that reimbursement would not be unfair. The parents are financially able to reimburse costs.

1. The parents shall reimburse the State of Wisconsin for attorney services in the total amount of:
