  - D. failed to perform any of his or her duties as a guardian under §48.023, Wis. Stats.

**I REQUEST THE COURT:**

1. Hold a hearing on this Request within 30 days.  
  
 I shall provide notice of the hearing and a copy of this petition to the child, his or her parents, the guardian, and any other persons required by the court at least 7 days before the date of the hearing.
  
2. Find cause for court action against the guardian by clear and convincing evidence and provide the following remedy:
  - Remove the guardian.
  - Remove the guardian and appoint a successor guardian.
  - Enter any other order that may be necessary or appropriate to compel the guardian to carry out the guardian's duties, including an order setting reasonable rules of visitation with the child.
  - Modify the duties and authority of the guardian as follows: \_\_\_\_\_

  - Require the guardian to pay any costs of the proceeding, including costs of service and attorney fees, if the court finds that the guardian's conduct was egregious.
