Wisconsin Supreme Court denies review of 39 cases

Madison, Wis. (Aug. 25, 2022) – The Wisconsin Supreme Court recently acted to deny review of 39 cases. The captions and case numbers of those cases are listed below. As the state’s law-developing court, the Supreme Court exercises its discretion to select for review only those cases that fit certain [statutory criteria](#) (see Wis. Stat. § 809.62). Except where indicated, these cases came to the Court via petition for review by the party who lost in the lower court.
