Office of Lawyer Regulation v. Guy K. Fish

On June 25, 2025, this court granted a motion by the Office of Lawyer Regulation (OLR) to temporarily suspend Attorney Guy K. Fish's license to practice law in the State of Wisconsin pursuant to Supreme Court Rule (SCR) 22.21 on the basis that Attorney Fish's continued practice of law "pose[d] a threat to the interests of the public and the administration of justice," due to allegations of misconduct in two pending disciplinary investigations.

On October 22, 2025, the OLR filed a letter with this court indicating that pursuant to SCR 22.21(3), the period of temporary suspension expires on October 24, 2025—by which time the rule requires the OLR to file a formal disciplinary complaint "or . . . show cause why the temporary suspension should continue." The OLR advises the court that the parties are in the process of preparing a stipulated resolution of the underlying disciplinary matters and requests that the court continue the temporary suspension.

Based on the contents of the OLR's filing, this court concludes that the OLR has established good cause to extend the temporary suspension. Therefore,

IT IS ORDERED that the Office of Lawyer Regulation's motion to continue the temporary suspension of Attorney Guy K. Fish's license to practice law pursuant to SCR 22.21(3) is granted;

IT IS FURTHER ORDERED that the Office of Lawyer Regulation's time to file a disciplinary complaint or other pleading resolving the underlying disciplinary investigations is extended by a period of thirty days from the date of this order; and

IT IS FURTHER ORDERED that the temporary suspension of Attorney Guy K. Fish's license to practice law in the State of Wisconsin shall remain in effect until further order of this court.
