On January 26, 2004, John A. Fiorenza was appointed referee in Case No. 03-3348-D. On October 4, 2004, Case No. 04-2633-D was filed with this court. By letter dated October 21, 2004 counsel for the Office of Lawyer Regulation (OLR) informed the court that he and counsel for Attorney Mandelman had agreed "that fairness and consideration to judicial economy would require these two disciplinary proceedings to be consolidated before Referee Fiorenza." By letter dated November 15, 2004 counsel for Attorney Mandelman joined in the request to have Referee Fiorenza appointed as the referee in Case No. 04-2633-D.

By letter dated November 16, 2004 counsel for the OLR withdrew its request that Case No. 04-2633-D be assigned to Referee Fiorenza and asked that the matter be assigned to a different referee. By letter dated November 18, 2004 counsel for Attorney Mandelman renewed his request that the court appoint Referee Fiorenza to be the referee in Case No. 04-2633-D.

The court finds that judicial economy would best be served by the appointment of Referee Fiorenza in both actions. Accordingly,

IT IS ORDERED that John A. Fiorenza is hereby appointed referee in No. 04-2633- D.
