The Court, by its Clerk and Commissioners, has entered the following order:

Defendant, Eleanor Urban, and defendant-appellant, Alan Ray Ward, have filed a document entitled "Notice of Intent to File a Petition in the Supreme Court and Notice to Proceed to File a Petition in the Supreme Court of Wisconsin, Petition for Review." The court considers this document to be a petition for review under WIS. STAT. §§ 808.10 and 809.62. The petition must be dismissed because it is untimely. A petition for review must be filed within 30 days of the court of appeals' decision disposing of the appeal, which occurred in this appeal on July 16, 2025, unless a timely motion for reconsideration is filed in the court of appeals. WIS. STAT. § 808.10(1). If a timely motion for reconsideration is filed in the court of appeals, the 30-day period for filing a petition for review starts on the date on which the court of appeals issues an order denying the motion for reconsideration. WIS. STAT. § 808.10(2). The defendants filed a motion for reconsideration on August 11, 2025, which was untimely because it was filed more than 20 days after the date of the court of appeals' decision disposing of the appeal. WIS. STAT. §§ 808.10(2) and 809.24(1). Consequently, the deadline for the defendants to file a petition for review in this court was August 15, 2025. Even if the motion for reconsideration had been timely, that motion was denied by the court of appeals in an order dated August 14, 2025, which would have meant the 30-day deadline for filing a petition for review in this court would have been September 15, 2025 (since the 30<sup>th</sup> day fell on a Saturday). Further, the fact that a party files multiple motions for reconsideration in the court of appeals does not extend the deadline for filing a petition for review in this court. Accordingly,

IT IS ORDERED that the document filed by defendant, Eleanor Urban, and defendant-appellant, Alan Ray Ward, entitled "Notice of Intent to File a Petition in the

Supreme Court and Notice to Proceed to File a Petition in the Supreme Court of Wisconsin, Petition for Review” shall be deemed to be a petition for review; and

IT IS FURTHER ORDERED that the petition for review is dismissed as untimely.
