The Court, by its Clerk and Commissioners, has entered the following order:

Plaintiff-appellant-petitioner, Jay Stone, has informed the court that he does not wish to stand on his previously filed petition for review, but instead wishes to file a new petition for review in his case, seeking review of the corrected opinion, dated as of October 14, 2025, but issued by the court of appeals on November 19, 2025. The court notes that the corrections included in the court of appeals' corrected opinion involve only paragraphs 5 and 55 and relate solely to whether the court of appeals is remanding the matter directly to the Wisconsin Elections Commission (WEC) or is remanding to the circuit court with directions to remand to the WEC. Consequently, to the extent that Mr. Stone wishes to file a new petition for review, any changes to his previously filed petition shall relate solely to the corrections made by the court of appeals. If Mr. Stone does not wish to address the subject of those corrections, he shall file a letter stating that he does not wish to address the subject of those corrections, in which case his previously filed petition shall stand, as will the response filed by the WEC. If Mr. Stone does file a new petition that includes changes that go beyond the subject of the corrections made to paragraphs 5 and 55 of the court of appeal's opinion, his new petition shall be rejected and his previously filed petition shall stand, as will the response filed by the WEC. If Mr. Stone does file a new petition that includes changes related solely to the subject of the corrections made to paragraphs 5 and 55 of the court of appeals' opinion, the WEC shall have 14 days from the date of filing of the new petition for review to file a new response. Accordingly,

IT IS ORDERED that, on or before December 29, 2025, plaintiff-appellant-petitioner may file a new petition for review so long as any changes from his previously filed petition for review relate solely to the corrections made by the court of appeals to paragraphs 5 and 55 of its October 14, 2025 opinion. If plaintiff-appellant-petitioner files

such a new petition for review, it will supersede the petition for review filed on October 21, 2025. If plaintiff-appellant-petitioner does not wish to file such a new petition for review, he shall file a letter stating that fact; and

IT IS FURTHER ORDERED that, if plaintiff-appellant-petitioner files a new petition for review that complies with the preceding paragraph, within 14 days of the filing of the new petition for review, the defendant-respondent, Wisconsin Elections Commission, may file a new response to the new petition for review or a letter indicating that it stands on its previously filed response.
