Respondent Waukesha County has filed a motion to supplement the record with the following items: 1) an Affidavit of Lissette Vale; 2) the Order for Extension of Commitment filed September 24, 2024 (Document 202); and 3) the Recommendation for Expiration of Commitment filed June 5, 2025 (Document 213). Petitioner R.D.T. does not object to supplementing the record with Documents 202 and 213, both of which were filed in the circuit court. R.D.T. objects to supplementing the record with the Affidavit of Lissette Vale. The court having considered all of the foregoing,

IT IS ORDERED that Respondent Waukesha County's motion to supplement the record is granted in part and denied in part. Waukesha County's motion to supplement the record with the Order for Extension of Commitment filed September 24, 2024 (Document 202) and the Recommendation for Expiration of Commitment filed June 5, 2025 (Document 213) is granted. Waukesha County's motion to supplement the record with the Affidavit of Lissette Vale is denied.

2024 (Document 202); and 2) the expiration of commitment order for R.D.T. filed June 5, 2025 (Document 213); and transmit the supplemented record to the court of appeals pursuant to Wisconsin Statute Section 809.15(4)(c).

IT IS FURTHER ORDERED that within 7 days after the date of this order petitioner R.D.T. must file a brief in this court; that within 20 days of filing respondent Waukesha County must file either a brief or a statement that no brief will be filed; and that if a brief is filed by Waukesha County, within 10 days of filing R.D.T. must file either a reply brief or a statement that no reply brief will be filed.
