The Court, by its Clerk and Commissioners, has entered the following order:

On September 11, 2025, the court of appeals issued an order denying Daniel Z. Maldonado's pro se motion for relief pending appeal, which had requested an order directing the Wisconsin Department of Corrections to immediately delete Mr. Maldonado's name and personal information from the sex offender registry. On September 12, 2025, the court of appeals denied what it construed as Mr. Maldonado's pro se motion for reconsideration of its September 11, 2025 order.

On October 15, 2025, Mr. Maldonado filed a petition for review regarding the court of appeals' September 11, 2025 order.

IT IS ORDERED that the petition for review is dismissed, for two reasons. First, it is untimely, as Mr. Maldonado did not file the petition for review with the clerk of this court within 30 days after September 12, 2025, the date the court of appeals denied what it construed as his motion for reconsideration of its September 11, 2025 order. *See Wis. Stat. §§ 808.10(2), 809.62(1m)(b).* Second, the subject of a petition for review must be the final decision of the court of appeals. *See Interest of A.R.*, 85 Wis. 2d 444, 270 N.W.2d 581 (1978). The court of appeals' September 11, 2025 order denying Mr. Maldonado's pro se motion for relief pending appeal does not meet this criterion. *See id.*
