Ninth, Tenth, and Eleventh Circuits. Ms. Woudenberg received her law degree from Valparaiso University School of Law in 2004.

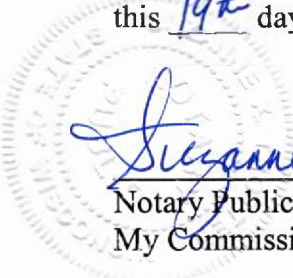
