The Court, by its Clerk and Commissioners, has entered the following order:

On December 16, 2025, respondent-appellant, Attorney Warren Lee Brandt, filed a motion for an extension of time to file his opening appellate brief in this matter due to health issues. In support of the motion, Attorney Brandt attached a doctor's letter and copies of medical records. On the same day the motion was filed, Attorney Brandt also filed a completed Form GF-245 (Confidential Disclosure of Information to be Sealed or Redacted). The court construes Form GF-245 as a motion to permanently seal the attachments to the extension motion. Those attachments have been temporarily maintained under seal pending the decision on the motion to seal. The court notes that the Form GF-245 motion to seal does not request that the court seal the extension motion itself.

On January 15, 2026, Attorney Brandt filed a second motion for an extension of time to file his opening appellate brief. In support of this motion, Attorney Brandt attached his own affidavit, another letter from a doctor, and additional medical records. Attorney Brandt's cover letter contained a request that the medical records be maintained as confidential. The complainant-respondent, Office of Lawyer Regulation, filed a response stating that it did not oppose an extension of time to February 5, 2026.

On February 19, 2026, the clerk of court received Attorney Brandt's opening appellate brief.

On March 23, 2026, the clerk of court received the Office of Lawyer Regulation's response brief. Therefore,

IT IS ORDERED that respondent-appellant's motions for extensions of time to file his opening appellate brief are granted, and his opening brief is accepted as filed as of February 19, 2026; and

IT IS FURTHER ORDERED that the original extension motion filed on December 16, 2025, with the attachments, shall be maintained under seal. The clerk of this court shall place a copy of the December 16, 2025 extension motion, without the attachments, into the public case file. The Form GF-245 filed on December 16, 2025, shall also be placed into the public case file; and

IT IS FURTHER ORDERED that the extension motion filed on January 15, 2026, with the attachments, shall be maintained under seal. The clerk of this court shall place a copy of the January 15, 2026 extension motion, without the attachments, into the public case file; and

IT IS FURTHER ORDERED that the Office of Lawyer Regulation's response brief is accepted as filed as of March 23, 2026; and

IT IS FURTHER ORDERED that the Attorney Brandt's reply brief shall be due on or before April 7, 2026.
