The Court, by its Clerk and Commissioners, has entered the following order:

Jason A. Olrich, pro se, initiated this miscellaneous XX proceeding in 2025 by filing various motions in the court of appeals. On December 8, 2025, the court of appeals ordered that no action would be taken on those motions because Olrich was represented by counsel at the time. On December 22, 2025, Olrich attempted to file an "appeal" of his underlying criminal conviction in Kenosha County Case No. 2015CF872 by filing documents captioned "Appeal to Wisconsin Supreme Court" and "Appeal on Illegal Sentence" with this court. On December 29, 2025, this court entered an order indicating that no action would be taken on these filings because there was no appeal pending relating to the underlying criminal case and Olrich was not seeking review of a final decision of the court of appeals, such that there was "no basis for this court to exercise jurisdiction in this miscellaneous appeal matter."

On April 13, 2026, Olrich filed a document with this court titled "Appeal On Anders Brief For Ineffective Assistance of Counsel For Sentencing [sic] After Revocation on Illegal Sentence Appellate Counsel Ineffective." This filing relates to the fact that on April 2 and April 9, 2026, the court of appeals entered further orders in this XX matter taking no action on motions and an attempted brief Olrich filed asserting ineffective assistance of counsel involving a no-merit appeal of his underlying conviction. The court of appeals' April 9 order indicated: "There is no no-merit appeal pending in this court and thus no basis for this court to accept the submission."

For the same reasons stated in this court's December 29, 2025 order, the court will take no action on Olrich's most recent filings in this XX matter. Olrich cannot initiate an appeal through an existing miscellaneous XX matter. This XX matter is closed.

IT IS ORDERED that the court will take no action on Olrich's April 13, 2026 filing in this miscellaneous XX matter, which is closed.

IT IS FURTHER ORDERED that the clerk of this court is directed to place any future filings from Olrich directed to this court in this miscellaneous XX proceeding in the file without a response.
