On July 1, 2020, defendant-respondents-respondents Michael A. Alderman, Alderman, Inc. d/b/a Jensen-Sundquist Insurance Agency, as the prevailing party in the above-captioned case, filed a notice of taxation of costs in the amount of \$850.36 pursuant to Wis. Stat. § 809.25. On July 6, 2020, plaintiff-appellant-petitioner, Emer's Camper Corral, LLC, filed an objection to the bill of costs, asserting that these costs are excessive.

The Clerk of the Supreme Court and Court of Appeals routinely determines the allowable costs of printing the required number of briefs at \$0.15/page. The response brief in question

contained 58 pages (including the brief, appendix and front and back covers). Accordingly, consistent with the statute and the routine practice of the Clerk's Office, allowable costs for 25 briefs are calculated as \$217.50.

IT IS FURTHER ORDERED that costs in the amount of \$217.50 be taxed against plaintiff-appellant-petitioner, Emer's Camper Corral, LLC.
