On April 9, 2019, this court accepted the court of appeals' certification in consolidated appeal case nos. 2016AP1688 and 2016AP2502.¹ On April 25, 2019, the Joint Committee on Legislative Organization, on behalf of the Wisconsin Legislature, filed a Petition to Intervene.
