On January 22, 2021, Attorney Patricia Sommer filed a no-merit petition for review on behalf of defendant-appellant, Marvin Greer, for review of the court of appeals' decision of December 23, 2020. Greer states he is still waiting to receive a complete record of the underlying court proceedings from Attorney Sommer.

IT IS ORDERED that to the extent she has not done so, Attorney Patricia Sommer shall serve upon Mr. Greer a copy of his entire record within seven days of the date of this order. See Wis. Stat. § 809.32(1)(d). Attorney Sommer shall advise the court, in writing, within 14 days of the date of this order, of her compliance with this order.

IT IS FURTHER ORDERED that Mr. Greer's motion for an extension of time to file his supplemental petition is granted. Defendant-appellant-petitioner shall have until April 19, 2021, to serve and file his supplemental petition for review. If the supplemental petition is not filed by that time, this matter will be disposed of based solely on the petition filed by Attorney Patricia Sommer.

IT IS FURTHER ORDERED that the no-merit petition for review is held in abeyance until further order of this court.
