On February 24, 2021 the court granted Kohler Company's petition for review and the Wisconsin Department of Natural Resources and Natural Resources Board's petition for cross-review in the above-captioned matter. Their opening briefs were filed on March 26, 2021.

On April 9, 2021, petitioners-appellants, Friends of the Black River Forest and Claudia Bricks, filed a motion to strike or, alternatively, motion to clarify regarding these opening briefs, together with a motion to enlarge time and to file a combined and overlength response brief.

The motion to enlarge time and to file a combined and overlength response brief is granted, as set forth herein. The court has determined that it would benefit from the petitioner and cross-petitioner's responses to the motion to strike or, alternatively, motion to clarify. Therefore,

IT IS ORDERED that Kohler Company and the Wisconsin Department of Natural Resources and Natural Resources Board, are each directed to file a response to the motion to strike or, alternatively, motion to clarify, within 14 days of the date of this order;

IT IS FURTHER ORDERED that the motion to enlarge time and to file a combined and overlength brief is granted, and the Friends of the Black River Forest and Claudia Bricks may file a single, enlarged response brief not to exceed 14,000 words which shall be filed no later than two weeks after the court rules on the motion to strike, or by May 6, 2021, whichever date is later.
