On May 4, 2021, counsel for respondent-appellant-petitioner, K.M., filed a motion in this court requesting an order directing the redaction of one word from respondent-appellant's initial brief in the court of appeals, or, in the alternative, an order allowing counsel to file substitute copies of that initial brief. The motion explains that, contrary to the requirements of Wis. Stat. § (Rule) 809.19(1)(g), the initial brief filed in the court of appeals included, on page 6, a quotation from a hearing transcript that included respondent-appellant's last name. Counsel for K.M. requests that they be allowed to redact this one word from page 6.

IT IS ORDERED that respondent-appellant-petitioner's motion is granted. Within seven days of the date this order, counsel for respondent-appellant-petitioner, K.M., shall file a revised version of the initial brief with the court of appeals, both in hard copy and electronically. The revised brief shall contain the redaction described above, but shall otherwise be identical to the initial brief previously filed.

IT IS FURTHER ORDERED that, upon receipt of the corrected version of the initial brief, the clerk of this court is directed to remove the initial brief filed July 22, 2020, and substitute the corrected version. Upon replacement by the clerk, the redacted version is deemed properly filed. The clerk of this court is directed to ensure that the corrected brief replaces the brief on file at the Wisconsin State Law Library.
