Do I have Right to Read my PSI Reports,  
FOR Taylor CO Stolen Car (1987) and 1987 Kunz  
murders, Conviction 1998?

The Appeals is holding me to Atty Standards  
and Refuse to File my Brief,

The Trial Court Refuses to let me Read  
either PSI.

Do I have Right to two (2) Full boxes of Legal  
WORK, that my Appeals Atty withheld when I took over  
my own Appeal in 2001?

The Appeals Court Refuses is holding me to  
Atty Standards and Refuses to File my Brief.

The Trial Court Refuses to order SPD Office  
to Produce those two boxes

Am I being denied meaningful accesses to the Courts, by Appeals Court Refusing to File my Brief and holding me to Atty standards, Jail/Prison Refusing to make copies (Prison) OR unreadable copies (Jail), Denying Legal Loans most ~~to~~ All Time (Prison), NOT selling carbon Paper on Legal Loans and when I do get Carbon from Canteen, it's defective (see back side of this sheet of paper), ~~Pen~~ "Flex Pen" that write couple pages and then stop OR/and become unreadable; Staff Refuses to give me my legal <sup>WORK</sup>, including Record to this Case (On 5-6-21 I Received 4-12-21 Appeals Court denial and I Finally Received Case # of this ~~case~~ Case) and other hurtels ???

## STATE OF CASE

In November 1987, Police informant Wayne wieler stole car in Taylor CO and I took blame for it. My Atty, Robert Brandner was conflict of ~~in~~for interest, working FOR DA OFFICE and knew I did not steal that CAR. Brandner had me Plead guilty to Burglary, which Put me at stolen CAR seen. This guilty Plead was used in the illegal search warrant in connection to Kunz Murder Case (which turn up no illegal activity, But got me labeled "Prime suspect" in murders)

Shortly after Late January 1988 (illegal) searches in connection with Kunz murder case, ~~Atty~~ PSI was done for Taylor CO stolen car, Atty Brandner never showed it to me NOR told me I had right to read it. I now believe that 1987 Taylor CO Stolen car PSI is full of false information.

In June 1998 I would be convicted on charges in connection with the July 1987 Kunz murders. I never got to read this PSI neither and I believe there is false information from Taylor CO 1987 Stolen car PSI in the 1998 PSI.

In 2001, SPD Office stop representing me:

① Lack of funding and ② Further appealing was a waist of time. I took over my own appeal. My Atty forwarded 17 boxes of legal work. She told me she consolidated 19 boxes down to 17 boxes. This is NOT true. She withheld 2 full boxes of legal work. OLR was no help at all. SPD office does not respond.

In 2008 and 2019, I filed motions with trial court, to order I be allowed to read Taylor CO 1987 Stolen car PSI and 1998 PSI on 1987 Kunz murder case, and to order SPD office to produce those two full boxes of legal work being withheld, (or reason for not producing them). The trial court never responded.

③

AFTER trial Court did Not Respond, I Appealed and Appeals Court Consolidated my 1st Trial (1988 CM 767) and 2nd Trial (1993 CF 196) (Don't know Appeals #s) and dismiss Appealed. I then Petition this Court For Review, which was denied. However, one Justice did used trial <sup>Judge</sup> to deal with the motions, which it did by denying both motions.

I then appealed again (2020 AP 1796 (1988 CM 767) and 2020 AP 1797 (1993 CF 196)) Again Appeals court consolidated and dismissed because my Brief was Not UP to Atty standards.

≠ NOW Requesting this Court to Grant Review of this case.

On 3-30-21, I was transferred From CCI to MNCJ and my legal work, which included a Petition For Writ of Certiorari, For these Cases/Appeals, in this court, was typed up and only needing a few minor touches to finish, was ready to send out. However, MNCJ Refuses to give me any of that legal work-supplies. Should I receive that legal work, I will forward Petition, to include with this bare-bone, but Timely Petition For Review, which this Court should grant.
