Pending before the court is the motion of Attorney Michael D. Mandelman to withdraw his petition for reinstatement, and the recommendation of Referee James J. Winiarski that the court grant Attorney Mandelman's motion. We accept the referee's recommendation.

Attorney Mandelman was admitted to practice law in Wisconsin in 1980. His license to practice law has been retroactively revoked since May 29, 2009. In re Disciplinary Proceedings Against Mandelman, 2014 WI 100, ¶62, 358 Wis. 2d 179, 851 N.W.2d 401.

On January 4, 2021, Attorney Mandelman filed a petition for reinstatement of his license to practice law in Wisconsin. The referee was appointed on March 24, 2021. On March 30,

2021, the referee was advised that Attorney Mandelman wanted to withdraw his petition for reinstatement.

On April 5, 2021, Referee James J. Winiarski issued a report recommending that the court grant Attorney Mandelman's request to withdraw his petition for reinstatement. The referee further states that Attorney Mandelman and the Office of Lawyer Regulation have stipulated that given the early withdrawal of the petition for reinstatement, the petitioner should not be assessed costs.

Upon review of the matter, we agree that it is appropriate to grant Attorney Mandelman's motion to withdraw his reinstatement petition. We further agree that no costs shall be assessed in this proceeding.

IT IS ORDERED that Michael D. Mandelman's motion to dismiss his pending petition for reinstatement is granted.

IT IS FURTHER ORDERED no costs will be assessed against Michael D. Mandelman.
