The court has construed the motion filed June 4, 2021 by defendant-appellant, James Earl Norwood, pro se, as a third motion for reconsideration of this court's February 24, 2021 order dismissing his petition for review as untimely. The court notes that in his pending motion the defendant-appellant states that he never received the court of appeals' December 21, 2020 order denying his timely filed motion for reconsideration. Given that the 30-day deadline for the submission of defendant-appellant's petition for review was triggered by the court of appeals' order denying the motion for reconsideration, Wis. Stat. § 808.10(2), the court will grant the defendant-appellant's motion for reconsideration, vacate its February 24, 2021 order, and reinstate the defendant-appellant's petition for review, which will be considered by the court in due course.
