By order dated July 19, 2021, the court construed a pro se letter filed by defendant-appellant, Curtis Von Brown, as a timely but nonconforming petition for review and ordered the defendant-appellant to serve and file a statement in support of the petition, conforming to the requirements of Wis. Stat. § (Rule) 809.62(2) and (4), by September 17, 2021. On July 21, 2021, Attorney James Rebholz filed a no-merit petition for review on behalf of Mr. Von Brown pursuant

to Wis. Stat. § (Rule) 809.32(4). The no-merit petition for review apparently crossed in the mail with the court's July 19, 2021 order. On July 30, 2021, Mr. Von Brown filed a pro se letter asking whether he is required to provide the court with the reasons why it should grant review of case. Accordingly,

IT IS ORDERED that, on or before September 17, 2021, the defendant-appellant, Curtis Von Brown, shall continue to be required to file a supplemental petition for review setting forth the information required by Wis. Stat. § (Rule) 809.62(2) (a), (b), (c), and (e), including a statement of the legal issues presented for review and an argument explaining why this court should grant review of those legal issues. See Wis. Stat. § (Rule) 809.62(1r) and § (Rule) 809.32(4). (Copies of Wis. Stat. § (Rule) 809.32 and Wis. Stat. § (Rule) 809.62, as well as a petition for review guide, are enclosed with Mr. Von Brown's copy of this order.) If Mr. Von Brown's supplemental petition (i.e., the statement in support of review) is not filed by September 17, 2021, the petition for review shall be decided based on the no-merit petition for review filed by Attorney Rebholz.
