U.S. Bank Trust Nat'l Ass'n v. Felt L.C. #2019CV164

The court having considered the motion filed on August 18, 2021, of petitioner, Christopher Stoller, pro se, to extend the time in which to file a petition to review the court of appeals' decision of July 21, 2021;

IT IS ORDERED that the motion is denied. The 30-day period in which to file a petition for review may not be enlarged. First Wisconsin National Bank of Madison v. Nicholaou, 87 Wis. 2d 360, 274 N.W.2d 704 (1979); and

IT IS FURTHER ORDERED that the motion itself shall be deemed a timely but nonconforming petition for review. However a statement in support of the petition, conforming to the requirements of Wis. Stat. § 809.62(2) and (4), must be filed with the clerk of this court by September 22, 2021. If the statement is not filed by that time, this petition will be summarily dismissed. No further time extensions will be granted.
