Clean Wisconsin has submitted via an email sent to the clerk of this court a motion for leave to file a nonparty brief amicus curiae, a proposed nonparty brief, and a proposed supporting appendix. The court notes that its August 31, 2021 order directed that responses by parties to the cases identified above could be filed as attachments to an email sent to the clerk of this court, with paper originals and copies to be delivered subsequently to the clerk. The August 31, 2021 order did not authorize nonparties to file motions via that method. Thus, the regular rules for filing documents apply to all other filings in these matters, including the filing of motions for leave to file a nonparty brief. Absent a particular order providing a different method of filing, the court's rules require that documents be filed by delivering a paper original and the required number of copies to the clerk of this court. It appears from the motion filed by Clean Wisconsin that its counsel misconstrued the August 31, 2021 order's directive of filing responses via email to apply to nonparty motions. In this particular instance, the court will permit the filing of the nonparty motion via email with paper originals and copies to be delivered subsequently. Accordingly,
