You are hereby notified that the Court, by its Chief Justice, has entered the following order:

The court, on its own motion, having concluded that the caption in these two matters should be amended to conform to past practice and the positions of the parties, and that the nature of these proceedings requires the establishment of specific guidelines for the conduct of oral argument;

IT IS ORDERED that the caption in these two matters shall be amended as follows. In Case No. 2019AP614-LV, the caption shall be amended to designate Robin Vos, in his official capacity as Wisconsin Assembly Speaker, Roger Roth, in his official capacity as Wisconsin Senate President, Jim Steineke, in his official capacity as Wisconsin Assembly Majority Leader, and Scott Fitzgerald, in his official capacity as Wisconsin Senate Majority Leader, as defendants-appellants. In Case No. 2019AP622, the caption shall be amended to designate Josh Kaul, in his official capacity as Attorney General of the State of Wisconsin, and Tony Evers, in his official

capacity as Governor of the State of Wisconsin, as defendants-respondents. Thus, the caption for both matters is now the same; and

IT IS FURTHER ORDERED that the clerk of this court shall issue a notice of amendment of caption that sets forth the full caption, as amended, for each of these two appellate proceedings; and

IT IS FURTHER ORDERED that the parties and amici shall use the amended caption and both case numbers in all future filings in this court. The parties and amici are not required to submit amended cover pages for briefs and other documents that have already been filed in these two cases.

IT IS FURTHER ORDERED that each side shall be granted 60 minutes to present oral argument. The defendants-appellants shall be on one side, and the plaintiffs-respondents and defendants-respondents shall be grouped together on the other side. The defendants-appellants shall present oral argument first and may reserve up to 10 minutes of their oral argument time for rebuttal. The plaintiffs-respondents and the defendants-respondents shall present oral argument following the completion of the initial argument by the defendants-appellants; and

IT IS FURTHER ORDERED that, on or before October 14, 2019, defendants-respondents on the one hand and the plaintiffs-respondents and the defendants-respondents on the other hand shall each submit a letter to the clerk of this court advising as to the order of presentation and allocation of argument time among them (including any argument time ceded to amici) and identifying the attorneys who shall be presenting oral argument for them; and

IT IS FURTHER ORDERED that, if any amicus wishes to participate in oral argument, the amicus shall request the parties with whom their position is more closely aligned to cede oral argument time to the amicus. On or before October 14, 2019, any amicus to whom argument time has been ceded shall submit a letter to the clerk of this court advising that the parties on one side have ceded argument time to that amicus, specifying the amount of argument time that has been ceded, and identifying the attorney who shall be presenting oral argument for the amicus.
