James Robert Rossin v. Circuit Court of Grant County

By order dated September 30, 2021, this court granted Petitioner James Robert Rossin's motion for an extension of time to file an addendum to the Motion for Writ he filed on September 28, 2021. On October 12, 2021, Attorney Lisa A. Riniker, Grant County District Attorney, advised the court that the underlying citations at issue in this matter are not handled by her office. Indeed, it appears that Mr. Rossin's writ petition is directed against the Circuit Court of Grant County. Accordingly, District Attorney Riniker's name will be removed from the distribution list for this case.

On October 26, 2021, Mr. Rossin requested another extension of time to file the addendum to his Motion for Writ, until January 15, 2022. He also requested a page limit extension and guidance on whether he can or should amend his initial writ petition.

IT IS ORDERED that the second motion for extension of time is granted. Petitioner James Robert Rossin's addendum to the Motion for Writ shall be filed on or before January 18, 2022;
