The court has before it the December 1, 2021 motion of Attorney Ellen Henak to participate in the December 10, 2021 oral argument in this matter on behalf of amicus curiae Wisconsin Association of Criminal Defense Lawyers (“WACDL”). The motion notes that Attorney Julianne Lennon, counsel for defendant-appellant-petitioner Nhia Lee, has agreed to cede a total of ten minutes of her time in the oral argument—five minutes for amicus curiae National Association of Criminal Defense Lawyers (“NACDL”), as authorized in our December 1, 2021 order, and five minutes for WACDL.
