IT IS FURTHER ORDERED that the statement in support of the petition must comply with the signature requirement set forth in Wis. Stat. § 809.107(6)(f); and

IT IS FURTHER ORDERED that failure to comply with these directives may result in the dismissal of the petition for review. See Wis. Stat. § 809.83.
