The court having considered the motion of petitioner-appellant, Thaddeus M. Lietz, pro se, for an order directing prison officials to pay the \$195.00 filing fee for petitioner-appellant's petition for review from his inmate release account;

IT IS ORDERED that the motion is denied. Section 814.29(1m) of the Wisconsin Statutes sets forth the procedure that a prisoner is required to follow in order to file a petition for review without prepaying the filing fee or giving security for costs. (A copy of Wis. Stat. § 814.29(1m) is being attached to defendant-appellant's copy of this order.)

IT IS FURTHER ORDERED that this matter will be subject to dismissal under Wis. Stat. § (Rule) 809.83 unless, within 20 days of the date of this order, petitioner-appellant pays the \$195.00 filing fee or shows good cause for waiving the prepayment of the filing fee by filing the Petition for Waiver of Fees/Costs-Affidavit of Indigency and the Authorization to Withhold Money from Trust Fund Accounts that are being sent to petitioner-appellant with his copy of this order, as well as a certified copy of his trust fund account statement for the previous six-month period. Wis. Stat. § 814.29(1m)(b)-(c). Once those completed documents are returned to the clerk of this court, this court will determine whether petitioner-appellant is entitled to file his petition for review without the prepayment of the filing fee. Petitioner-appellant is advised that if the court determines that he has assets in trust fund accounts, whether accessible to the prisoner only upon release or before release, the court will require that those funds be used to make an initial payment, in whole or in part, of the filing fee. Wis. Stat. § 814.29(1m)(d).
