The court having considered the State's December 3, 2021 motion to file a sur-reply to Nhia Lee's reply brief filed July 23, 2021, as well as Lee's objection to the State's motion;

IT IS ORDERED that the State's motion to file a sur-reply brief is denied.

REBECCA GRASSL BRADLEY, J. (*dissenting*). A majority of the court denies the State's motion to file a sur-reply brief without any explanation of its rationale for this ruling. I would grant the State's motion and accept the State's brief in the interest of having the court fully apprised of the parties' arguments in preparation for oral argument. Regardless, the court should explain its procedural rulings in order for appellate attorneys to conform their practices accordingly.
