On July 20, 2021, a telephonic hearing was held on Respondent Madaleine Mulrey's *Motion to Reconsider Default Judgment*. "Following the appointment of a referee, the parties shall file all papers and pleadings with the supreme court and serve a copy on the referee."


In order to have a complete record of this matter before the Supreme Court:

IT IS ORDERED that Respondent Madaleine R. Mulrey shall file all original documents or copies of those documents that have been sent to the referee as part of these proceedings with the Supreme Court.

IT IS FURTHER ORDERED that since some or all of these documents are not dated that Respondent Mulrey also file with each document the transmittal email showing the date sent to the referee so that the record is complete and each document can be referenced as to the date sent.

IT IS FURTHER ORDERED that these filings be completed and this Order complied with on or before August 6, 2021, and that Respondent Mulrey shall send to the referee a certification or statement that she has complied with this Order on the date the documents are sent to the Supreme Court.
