The State Public Defender (SPD) has filed a petition for writ of habeas corpus on behalf of defendant-appellant-petitioner, Miguel A. Meza. The SPD explains in the habeas petition that Attorney Kirk Henley, the appellate counsel it appointed for Mr. Meza, rendered ineffective assistance when he mistakenly believed a no-merit petition for review could be filed via the appellate eFiling system, and therefore failed to file a hard copy of the no-merit petition for review until after the deadline set forth in Wis. Stat. § 808.10.

IT IS ORDERED that the petition for writ of habeas corpus is granted, ex parte; and,

IT IS FURTHER ORDERED that the relief requested in the habeas petition, that the no-merit petition for review filed in State v. Meza, No. 2021AP1044-CR, be reinstated and deemed timely-filed, is granted. See State ex rel. Schmelzer v. Murphy, 201 Wis. 2d 246, 548 N.W.2d 45 (1996); and,

IT IS FURTHER ORDERED that pursuant to Wis. Stat. §§ 809.32(4) and 809.62, Miguel A. Meza may file a supplemental petition with the clerk of this court by October 13, 2022. The supplemental petition shall state reasons in support of the review and satisfy the requirements of § 809.62(2)(a), (b), (c), and (e). If no supplemental petition is filed within the prescribed time, this matter will be submitted to the court for appropriate action; and,

IT IS FURTHER ORDERED that the State of Wisconsin shall file its response to the no-merit petition for review and any supplemental petition by October 27, 2022. The parties will thereafter be notified in due course of this court's disposition of the no-merit petition for review.
