On October 14, 2022, a no-merit petition for review pursuant to Wis. Stat. §§ 808.10 and (Rule) 809.32(4) was filed on behalf of M.J.C. by Attorney Carl W. Chesshir.

The no-merit petition for review lacks the required handwritten signature from Attorney Chesshir. See "In re Interim Court Rule Governing Electronic Filing in the Supreme Court," S. Ct. The no-merit petition for review also lacks the required certification of compliance with Wis. Stat. (Rule) 809.19(12). See id. ("An attorney filing a brief, appendix, petition for review, or response to a petition for review must file an electronic copy of the document with the court in addition to the paper copies. An attorney filing an appendix may file an electronic copy in addition to the paper copies. The attorney must certify that the electronic copy is identical to the paper copy. See former §§ 809.19 (12) (f) and (13) (f) and Comment, 809.32 (1) (fm), 809.62 (4).")
