On November 7, 2022, Robert Dorgay, pro se, filed a document in this court titled both "Petition for Review of Decision By Court of Appeals, District 1, In Case No. 2021AP954-CR, The Honorable Judge Maxizne [sic] White" and "Petition for Supervisory Writ Pursuant to § 809.71." On November 17, 2022, the court dismissed the petition for review as premature since the order Mr. Dorgay was asking this court to review was not a final decision of the court of appeals. See In Interest of A.R., 85 Wis. 2d 444, 270 N.W.2d 581 (1978). On December 5, 2022, Mr. Dorgay filed a motion for reconsideration of this court's November 17, 2022 order.

IT IS ORDERED the motion for reconsideration is denied; and

IT IS FURTHER ORDERED that the petition for supervisory writ is dismissed. This court will not exercise its supervisory jurisdiction where there is an adequate alternative remedy. See generally Wis. Stat. § 809.71 and accompanying Judicial Council Committee's Note, 1981. After
