Shellow v. Forester-Hoare, L.C. #2021PR35

On December 27, 2022, this court granted the second motion of appellant, Sean Forester-Hoare, pro se, to extend the time in which to file his statement in support of his petition for review. On January 3, 2023, the court received Mr. Forester-Hoare's statement in support and a letter, dated December 28, 2022, requesting that, if the court had granted his second motion for extension, the court stay submitting the enclosed statement, as he intends to hire counsel to represent him.
