ORDER FOLLOWING HEARING


On January 4, 2023 at 10:00 a.m. a hearing was held via Zoom in this matter. The Office of Lawyer Regulation appeared by Attorney Jonathan E. Hendrix, and Vladimir Gorokhovsky appeared *pro se*. Based upon the discussions and arguments during the hearing:

IT IS ORDERED:

1. Respondent's *Motion to Dismiss Merkel's Claim* is denied for the reasons stated on the record.
2. Respondent's *Motion to Compel Notice of Deposition Pursuant to Rule 37(d) of Fed. R. Civ. Procedure and for Order to Extend Time to Conduct Plaintiff's Fact Discovery* is denied for the reasons stated on the record.
3. OLR may file a Second Amended Complaint by February 3, 2023.
4. Vladimir Gorokhovsky shall sign and return the medical release provided by OLR by March 6, 2023.
5. Any motions for reconsideration shall be filed with the Clerk, a copy provided to the Referee and the other party by March 6, 2023.

6. Responses to any motion for reconsideration shall be filed with the Clerk, a copy provided to the Referee and the other party by March 23, 2023.
7. The referee will hold a hearing on any motion for reconsideration on March 27, 2023 at 2:00 pm via Zoom with the OLR arranging for the services of a court reporter.
8. On or before April 10, 2023, each party shall file with the Referee, and provide to the other party, a final Witness List and a complete copy of exhibits they intend to use at the hearing, placed in a binder in the order of intended use.
9. The discovery deadline for both parties is May 1, 2023, with one limited exception as follows: If at hearing, OLR calls Irene Kalavsky as a witness and the Respondent can demonstrate surprise at her testimony, the referee will adjourn the hearing and allow the Respondent to depose Kalavsky on those matters in which he can demonstrate surprise.
10. A Final Pre-Trial Conference will be conducted on May 4, 2023 at 2:00 p.m.
11. A hearing will be held in this matter on May 8 through May 10, 2023 commencing at 9:00 am each day at the Milwaukee Bar Association. OLR shall reserve a room and secure a court reporter.
