Shellow v. Forester-Hoare, L.C. #2021PR35

On March 20, 2023, this court entered an order requiring appellant-petitioner, Sean Forester-Hoare to either remit the \$195.00 filing fee to the clerk of this court, or otherwise show good cause for waiving the fee by filing the Petition for Waiver of Fees and Authorization to Withhold Money from Trust Fund Accounts forms. On March 22, 2023, Mr. Forester-Hoare filed a motion requesting to supplement his petition for review in order to include a request for oral argument. On April 3, 2023, Mr. Forester-Hoare filed various motions which this court construes to be motions for an extension of time to file his indigency forms. The court notes that also on April 3, 2023, Mr. Forester-Hoare filed a petition for waiver of the filing fee for the petition for review, but the waiver petition is incomplete because it was not notarized.

IT IS ORDERED that the motion to supplement the petition for review is granted. The motion itself will serve as the supplement. No further supplement will be accepted; and,

IT IS FURTHER ORDERED that appellant-petitioner, Sean Forester-Hoare shall, within 30 days of the date of this order, remit the \$195.00 filing fee to the clerk of this court, or otherwise show good cause for waiving the fee by filing a complete and notarized Petition for Waiver of Fees and Authorization to Withhold Money from Trust Fund Accounts forms.¹ Mr. Forester-Hoare is reminded that he must also file a certified copy of his trust fund account statement for the previous six-month period. A copy of this order is being sent to Green Bay Correctional Institution in order help expedite obtaining a copy of the trust fund account statement. If all of the following completed documents are not filed within 30 days from the date of this order, the petition for review will be summarily dismissed.
