On May 2, 2023, Attorney Joseph N. Ehmann of the Office of the State Public Defender (SPD) filed a petition for review on behalf of defendant-appellant, Steven M. Nelson, seeking review of the court of appeals' decision of April 4, 2023. Attorney Ehmann also filed motions requesting that the court permit the SPD to appoint successor counsel for the defendant-appellant due to medical issues being encountered by the defendant-appellant's current counsel and that the defendant-appellant be permitted to file a statement in support of the petition within 30 days. Accordingly,

IT IS ORDERED that the petition for review filed on May 2, 2023, which lacks certain of the requirements for a petition for review, is nonetheless accepted for filing as of May 2, 2023; and

IT IS FURTHER ORDERED that the motions filed by Attorney Ehmann on behalf of the defendant-appellant are granted. Attorney Vicky Zick is permitted to withdraw from the representation of the defendant-appellant as of the date of this order, and the Office of the State Public Defender shall appoint successor counsel for the defendant-appellant.
